This grant of rights shall be in addition to any rights possessed by a member of the general public and shall not be construed to prejudice or operate in derogation of any rights, licenses or privileges which the Grantee or the Grantee's licensees, successors, employees, agents or assigns may be entitled to as a member of the general public, without reference to this instrument.
